Chairman Flexer and Fox, Ranking Members Sampson and Mastrofrancesco, thank you for giving me the opportunity to speak on proposed Bill # 6205 and express my firm opposition to the proposed changes to voter guidelines already in place, per our CT Constitution.

As the Founder and CEO of Fight Voter Fraud Inc, a 501 (c) 4 nonprofit organization, we firmly believe in "One vote for one legal voter. ©". In the State of Connecticut, this is not happening. Saying there is no voter fraud in CT without the Secretary of the State ensuring that only eligible voters on the 2.505M Voters Registration list is like saying "You have to pass the Bill before you can find out what is in it."

In the coming weeks and months, we will be submitting proof of this fact. First, a special thanks to Rep. Blumenthal, during my last interaction on Zoom, he insisted we submit to the SEEC, the 103 CT voters that had two different voter IDs, same/similar names, same address, same city/town and same date of birth. They appear to have voted twice using both Voter ID #s. This information was found in the Secretary of the State's own Voter Registration database. We filed yesterday, not only with the Secretary of the State, but the SEEC and the proper Federal authorities. There will be many more filings, as we bring forward the hard evidence of all the irregularities within the Secretary of the State's Voter Registration database.

Before we can entertain making additional changes to how eligible voters can register to vote through absentee ballot and making changes to our CT Constitution, we need to clean & maintain the voters rolls of people that no longer live in the State of CT, of those that have passed away and remove the 200,000+ inactive voters. We need to clean the voter rolls, so we know exactly who is eligible to vote in our elections.

Expanding the Absentee voting and adding an unconstitutional change to allow anyone for any reason to vote absentee because of Covid 19 has and will continue to violate the rights of all CT citizens. We the people are delegated by our CT Constitution to allow these changes – not the

legislature by using the Covid as an excuse. Mind you, we at Fight Voter Fraud, are not against the proper use of Absentee ballots; they need to be used only as our Constitution has directed.

Our system before Covid wasn't the best since the voter rolls were and are not accurate, but at least there was some oversight by the Town Clerks and Registrar of Voters verifying the accuracy of the applications. The overburden on Town Clerks and Registrar of Voters by having hundreds of thousands of Absentee ballot applications put into their system caused even further issues when a system was not designed for this ten-fold increase and verifications may have been overlooked because of the workload.

Don't expand any voting laws until the facts, all the facts are investigated. Ask the Secretary of the State to do her own audit on her database and verify those eligible are the only ones allowed to vote.

In conclusion, the Covid excuse should no longer be an issue here in CT. We had over a million people vote in person during the November election and no one got Covid and died from standing in line. Vote against wasting more resources and taxpayer dollars and focus on "Cleaning the voter rolls" instead of violating our CT Constitution, again.
