I do not believe the Town Clerk is responsible for the certifications of the Registrar of Voters. Also the ED-632 is a signed legal document under penalty of law that has to be completed by the Registrars and sent to the Secretary of the State.

We don't care who gets us the information. We just need it to verify the eligibility of the Registrars under CT State Statutes.
