Additional information requested has not been sent to us. After being sent the incomplete list, we have found that the information provided was inaccurate. Hence, we are requesting under FOIA, that you provide us with the information requested.

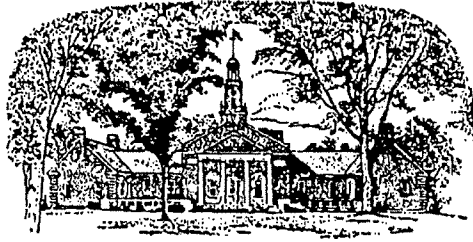
