Alden – We need a copy of the actual signed ED-632. We can not go by typed information. The SOTS will not be sending you a document to fill out the ED-632. You can use the Exhibit B link for the 2017 document and just put the dates for 2024.

We are putting together a comprehensive document on all 169 town Registrars – 338 Registrars in CT and their compliance with CT State Statutes for – Certification, education hours and ED-632. This document will be made public and we want to have all accurate information. Unfortunately, the SOTS doesn't even have the accurate information, so we are unable to rely on them.

Any unofficial documents will be noted as not provided. It is highly unlikely the Registrars signed off on the ED-632 without keeping a copy for town records especially since it is a felony to incorrectly fill out an ED-632 and is required under state statute to be done. I am confident they understand the gravity of the document they signed and the need to retain a copy.

Please ask them again for a copy. If you don't have it, we will note it in the file and on our public document and consider our FOIA closed.
