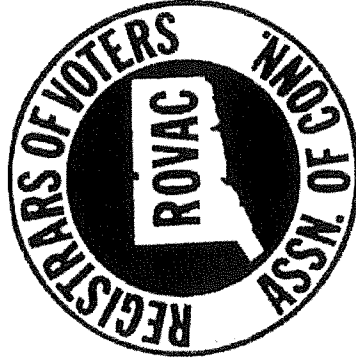
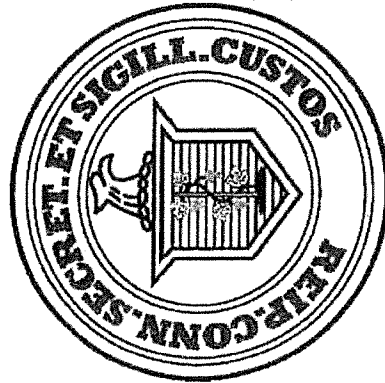

Hello Tammy,

Thank you for this request. The UConn School of Public Policy took over the administration of the ROV Program in Summer 2023 – prior to that point records were maintained by a different unit within UConn – UConn CITI. In 2019 CITI staff implemented a process whereby copies of all certificates and other records were saved electronically and all hard copy certificates were mailed with proof of delivery required to ensure each registrar received them. Prior to this date, there was another administrative group which preceded CITI in maintaining the program and former practice was to document the course and exam results in an original database. Hard copy certificates were generated, sent to the SOTS for signature. Copies of the signed certificates were not found in CITI's electronic filing system, and their staff have not located any other records documenting this, leading CITI to believe that scanned copies of signed original copies were not kept.

Prior to 2020 the CITI group's retention of copies hadn't been an established practice and it was standard procedure to mail signed certificates to each registrar. The 'Certified Dates' listed in CITI's database from 2017-2020 represent the proof of passing the exam. Attached is a summary spreadsheet, provided by UConn CITI, of all Registrars that had been certified from 2017 to 2023 when they concluded their administrative oversight. This attached file is a copy of that database report, labeled with your name, and currently filtered to 2018 – your completion year.

I hope this is helpful – please let me know if you need anything else. Thank you.
